**LOCAL LAW NO. 2 OF 2025**

**A Local Law Amending Local Law #4 2024 to Include Additional Public Property in the  
Revised Zoning Map**

Be it hereby enacted by the Village Board of the Village of Middleburgh, Schoharie County, New York, as follows:

**SECTION I: AUTHORITY**

This Local Law is enacted pursuant to the authority of Section 10 of the Municipal Home Rule Law, and in accordance with the New York State Village Law and Section 1.1 Attachment IV of the Zoning Law of the Village of Middleburgh.

**SECTION II: PURPOSE AND FINDINGS**

**WHEREAS**, The Village Board has determined there is a desire and a need within the Village of Middleburgh to change the zoning of tax parcel 106.15-4-2, which has been acquired by the Village since the amended zoning map was adopted, from Residential 2 to Public so as to reflect its current ownership and uses, and to amend the current zoning map of the Village to reflect this change.

**SECTION III: OFFICIAL ZONING MAP AMENDED**

Therefore, **Be It Resolved**, The Village Board hereby amends the official Zoning Map of the Village of Middleburgh to make tax parcel 106.15-4-2 a Public Property.

**SECTION IV: SEVERABILITY**

If a court determines that any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this Local Law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

**SECTION V: REPEAL**

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed.

**SECTION VI: EFFECTIVE DATE**

This Local Law shall take effect immediately upon the filing in the office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.
