Trustee Tinker made a motion, seconded by Trustee Adams, to open Public Hearing on 2026 Village Budget, at 7:05pm. Upon a roll call vote, this motion was unanimously carried 4-0.

Trustee Young made a motion, seconded by Trustee Tinker, to open Public Hearing at 7:05 PM on Local Law #2-2025: A Local Law Amending Local Law #4-2024 to Include Additional Public Property in the Revised Zoning Map. Upon a roll call vote, this motion was unanimously carried 4-0.

Chief Wayman Monthly Report: Chief Wayman thanked the Board for the tax increase being allocated to the Fire Department, and requested permission to transfer old off-road vehicle to membership and use funds to purchase replacement. Trustee Young made a motion, seconded by Trustee Tinker, to approve transfer. Upon a roll call vote, this motion was unanimously carried 4-0.

Chief Wayman also provided the list of Fire Department Line Officers for 2025-2026. Trustee Tinker made a motion, seconded by Trustee Adams, to approve the officers list. Upon a roll call vote, this motion was unanimously carried 4-0.

Code Officer Fink Monthly Report: Absent; Mayor Knight noted 140 Wells Ave has been cleaned up, and no cars are parking overnight at Depot Museum anymore.

Clerk Kelley Monthly Report: New Deputy Clerk Alecia Seletsky is off to a good start, Water & Sewer bills were sent out, and everything else is going well.

Holidays are around the corner, which means Candy Canes will be here soon. Trustee Tinker made a motion, seconded by Trustee Adams to approve Middleburgh Rotary Club to place Candy Canes on Parking Meters from Friday November 28th, 2025 to January 6th, 2026.

The Board discussed different Health Insurance plan options for the upcoming year. CDPHP and MVP plans were compared. It was consensus of the Board to add Health Insurance meeting with our representative Sean Byrne to the agenda for the special appointment meeting scheduled for December 1st, 2025.
